Section 708A Cleansing Notice

The Company hereby confirms that 74,000,000 ordinary shares at \$0.525 per share (**Shares**) were issued to TheChairmen1 Pty Limited (**Chairmen**) on 28 February 2013 without disclosure to investors under Part 6D.2 of the *Corporations Act 2001* (Cth) (**Act**).

Chairmen is the controller of the Company.

The Company and Chairmen state that this notice is given to ASX Limited (**ASX**) under section 708A(5)(e)(ii) of the Act in compliance with the requirements of section 708A(6) of the Act and that as at the date of this notice the Company:

 - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) the rights and liabilities attaching to the Shares.
