Amendment to Appendix 3Y lodged 26 March

I refer to the Appendix 3Y lodged by Guildford Coal (ASX: GUF) Thursday, 26 March, 2015. Attached is an amended Appendix 3Y which corrects the names of the entities in which the Director holds shares. These are C1 Commodities P/L and Auspicious Future Ventures Ltd. After the change, the total number of shares held by C1 Commodities P/L is 100,000,000 and for Auspicious Future Ventures, the total shares held is 109, 033,041.

The original Appendix 3Y was not lodged within the required 5 business days because of an administrative oversight which was only uncovered in the past 2 days as part of a routine audit of the company's records. The form was lodged immediately upon identification of the error.

The Company and all directors are aware of the requirements of listing rule 3.19A. It has the necessary verification, reporting and notification policies in place to ensure compliance with its disclosure obligations. The Board and Management of Guildford Coal have a strong commitment to continuous disclosure.

The company is of the view that the current arrangements regarding changes to directors' interests are adequate and are being enforced. The Company will, in the light of this oversight, review its procedures to ensure future compliance with listing rule 3.19B.
